

PRIVACY STATEMENT

This Privacy Statement (**Statement**) is presented to you by Capstone Financial Services Limited, trading as Agria Petinsure and Petinsure of Ulysses House, 23/24 Foley Street, Dublin 1, Dublin, D01 W2T2, Ireland (company registration number 451193) (**Capstone**, we, us and our). Capstone is the controller of your personal data when you visit the website <u>www.agriapetinsure.ie</u>, when you take out an insurance policy with us and/or when you avail of our other services. Capstone is committed to ensuring that your privacy is protected.

This Statement sets out the personal data that we process about you, the legal bases according to which we process such personal data, and how and why we process it. Please read this Statement carefully to understand our practices regarding your personal data and how we will treat it. This Statement is being provided to you in line with our obligations under the General Data Protection Regulation (**GDPR**), the Data Protection Acts 1988 to 2018 and other applicable data protection law.

PERSONAL DATA WE COLLECT AND PROCESS

As used in this notice, "personal data" means any information relating to a living individual who can be identified directly from that information or indirectly in conjunction with other information which we may hold or have access to. "Processing" means any operation or set of operations which is performed on personal data or on sets of personal data, whether or not by automated means, such as collection, recording, organisation, structuring, storage, adaptation or alteration, retrieval, consultation, use, disclosure by transmission, dissemination or otherwise making available, alignment or combination, restriction, erasure or destruction.

We will collect and process the following categories of personal data about you:

- Personal data that we collect directly from you:
 - **Identification Information:** your title, name, address, date of birth;
 - **Contact Information:** your address, e-mail address and phone number;
 - Insurance Policy Information: your bank account and/or credit card information and information on your pet/pet ownership;
 - Technical Information: such as your IP address, domain name, hardware, operating system, browser, system activity, internal and external information related to website pages that you visit, clickstream information and geolocation data; and
 - **Correspondence Information:** information that you may give us by corresponding with us by post, phone, e-mail or through our website.

You are not obliged to provide us with your personal data. However, if you do not, we will not be able to carry out the services you have requested of us.

RECIPIENTS WE MAY SHARE YOUR PERSONAL DATA WITH

We may share your personal data with members of our corporate group, agents, contractors or partners of Capstone in connection with services that these individuals or entities perform for or with Capstone. These include but are not limited to, insurance companies from whom we receive insurance products, data storage providers, systems administrators and developers, payments processors, providers of archiving services, private detectives, barristers, third party experts, accountants, financial and tax advisors or external auditors or any other third-party provider who assists us in the provision of our services to you and to our insurance partners. We may disclose your data in the event that we sell or buy any business or assets, in which case we may disclose your personal data to the prospective seller or buyer of such business or assets. We may disclose or share your data in order to comply with any legal obligation or in order to enforce or apply our General Terms and Conditions.

We may transfer your personal data outside of the European Economic Area (**EEA**) for storage and to our partner companies and other recipients. We will take appropriate mechanisms to safeguard your rights and freedoms to provide an adequate level of protection of personal data in respect of such third country data transfers. Such mechanisms include the adequacy decision under Article 45 of the GDPR in respect of data transfers to the United Kingdom or entering into standard contractual clauses under Article 46.2 of the GDPR. DATA SECURITY

We take our data security responsibilities seriously, employing the most appropriate physical and technical measures, including staff training and awareness. We review our data security measures and procedures regularly. Unfortunately, the transmission of information by means of the internet, including through e-mail, is not completely secure. Although we will do our best to protect your personal data, we cannot guarantee the security of your personal data transmitted to or from us by means of e-mail and any such transmission is at your own risk.

DATA RETENTION

In general we will only keep your personal data for as long as is necessary for the purpose for which it is collected and for a reasonable period of time thereafter. Where we process your personal data in connection with a contract with you, we will typically retain your personal data for as long as is necessary to fulfil our obligations to you under the terms of the contract plus a reasonable period of time thereafter. In the case of insurance provision, we are required to hold your personal data for a period of 6 years post termination of our contract with you. Once we have determined that we no longer need to retain your personal data, we will delete it from our systems. However in relation to all personal data which we process, we may retain it for a longer period of time if we require it in relation to a legal claim or if we are required to retain it by applicable law/regulation.

YOUR RIGHTS

As a data subject, you have the right to request that we:

- rectify any inaccurate personal data or complete any incomplete personal data we might have about you;
- erase your personal data;
- restrict our processing of your personal data; and
- furnish you with the personal data which you provided to us in a structured, commonly used and machine-readable format.

Where we process your personal data solely on the basis of your consent, you are entitled to withdraw your consent at any time. This will not affect the lawfulness of our processing before the withdrawal. You also have the right to object to your personal data being processed on the basis of our legitimate interests (or those of a third party). We will cease processing your personal data, unless the processing is based on compelling legitimate grounds or is needed for the exercise or defence of legal claims.

These rights are not absolute and the exercise of your rights might be subject to certain conditions prescribed by law. We might require further information from you before we can respond to your request. You may exercise your rights by contacting us via the Contact Details provided above.
